2 PREFACE

Please read this manual carefully. The correct understanding and execution of the instructions is obligatory for using the CRM 3000 safely and correctly. Keep this manual handy whenever you are working with CRM 3000.

This manual is also available at https://dualinventive.com/en/downloads/. If you encounter any ambiguities while using the CRM 3000, report them via info@dualinventive.com or by telephone.

The CRM 3000 is designed to contribute to the *optimal distribution of rail capacity*, considering the ease and safety of track monitoring.

No rights can be derived from the information in this user manual. The reproduction or distribution in print, written and/or audio-visual form is prohibited, unless Dual Inventive has permitted this beforehand.

Dual Inventive has originally written this manual in English. If anything is unclear or deviates from the original in a translated version, the original English document is leading.

2.1 Purpose user manual

The purpose of this user manual is to instruct the user on the correct and safe use of the CRM 3000. The CRM 3000 is a *sensor* for the *remote monitoring of railway systems*, combined with the web and mobile application versions of MTinfo 3000-Insight.

There are two versions of the CRM 3000: the standard version, which updates its data every hour and the Variable Threshold (VT) version, which uploads data based on the temperature it measures. The thresholds of the VT versions are pre-configured by Dual Inventive in collaboration with customers

This user manual contains instructions regarding:

- 1. Personal safety and product safety that must be observed to avoid risks that could lead to physical and/or property damage.
- 2. Use of the CRM 3000.

2.2 Users of CRM 3000

Typical users of the CRM 3000 are:

- 1. The work planner prepares and manages the web interface MTinfo 3000-Insight and assigns the location for installing the CRM 3000s on the railway track.
- 2. The installer is the track worker responsible for installing the CRM 3000 on the railway track.
- 3. The end user monitors the track temperature.

Every user of the CRM 3000 must be authorized by the administrator of the user's company for the right access and user rights for MTinfo 3000-Insight.



NOTE

The CRM 3000 must only be used by trained, certified, and competent users.

3 INTRODUCTION

3.1 Intended use

The CRM 3000 is intended to remotely monitor railway systems. The CRM 3000 measures the rail temperature and its orientation on the track. The CRM 3000 is used in combination with the MTinfo 3000-Insight web application and the MTinfo 3000-Insight mobile app 'The RailCloud - Work Management'. Both applications are used for monitoring and management of one or more CRM 3000.

3.2 Non-intended use

Any other use than the intended use is prohibited.



WARNING

Non-intended use could have consequences for the personal safety and can cause material damage to the CRM 3000 and its surroundings.



NOTE

In case of non-intended use, the warranty of the CRM 3000 is voided.

4 PRODUCT DESCRIPTION

4.1 CRM 3000

The CRM 3000 is a *sensor for remote monitoring of railways*. For the user, the CRM 3000 is a 'black box', as it cannot be opened and lacks control buttons. The compact device is *magnetically attached* to the object being monitored, ensuring simple and swift installation.

The standard CRM 3000 has an internal battery built to last for a default period of 5 years.



NOTE

The lifetime of CRM 3000 varies based on usage and area connectivity.

The CRM 3000 measures the *temperature* of the object and its *orientation through X, Y and Z axis values*. The temperature measurement is intended for reliable monitoring of changes in rail and object temperatures. The orientation measurement is intended to monitor the alignment of

objects, such as signs, relay cabinets or signals. The orientation measurements can also be used to indicate whether the CRM 3000 has fallen off or has been removed from the object.

The CRM 3000 communicates with MTinfo 3000-Insight using *NB-IoT* technology. The measured values are reported back to the user via MTinfo 3000-Insight. In this way, users can both monitor and manage all CRM 3000 devices easily using the MTinfo 3000-Insight applications.

4.2 Identification

The CRM 3000 has an ID sticker with a serial number and a QR-code (see Figure 1).

4.3 MTinfo 3000-Insight web and mobile app 'The RailCloud – Work Management'

The CRM 3000 device works with the MTinfo 3000-Insight web and the mobile application 'The RailCloud-Work Management'.



NOTE

For more details on the MTinfo 3000-insight web application 'The RailCloud-Work Management', please check their respective manuals on the *Dual inventive website*.

4.4 Terms of use

4.4.1 CRM 3000

- 1. Non-SIL certification: The CRM 3000 is not SIL (Safety Integrity Level) rated and is therefore not certified to be used for safety purposes.
- 2. Quarantine and Damage control: Do not use the CRM 3000 if it has been damaged or shows defects. Quarantine the CRM 3000. The CRM 3000 should not have major damage; a slight scratch is acceptable. Please contact Dual Inventive.
- 3. Professional repair: Never perform repairs to the CRM 3000 yourself.
- 4. *Installation safety measures:* Make sure that when installing the CRM 3000, the device does not get damaged by on-track equipment or other tools in line with local regulations.
- 5. *Precautions*: Avoid dropping the CRM 3000. The device contains components that can withstand shocks and vibrations, but the device can break down.

4.4.2 MTinfo 3000-Insight web and the app



WARNING

Always respond promptly to service alerts from MTinfo 3000-Insight (set by the customer) when issues arise.

- 1. Authorized usage: You must only use MTinfo 3000-Insight when you are authorised by the user company for the correct right access and user rights. Dual Inventive creates a user account for the company. This user account is the company's administrator and is the nominated contact person for your company. The administrator is responsible for creating and managing users and their respective rights for using Dual Inventive product(s), in such a manner that misuse is avoided. You are responsible for keeping your password secret and working safely with Dual Inventive products.
- 2. Missing login information: If you have lost login details, immediately contact the company administrator within your organization to block the account to avoid misuse. If internet is available, please go to MTinfo 3000-Insight and change the password to avoid misuse.

- 3. Compatibility issues: Incompatible hardware, software settings, firewalls etc. could limit the connection to MTinfo 3000-Insight. When you encounter any issues, please discuss it with your IT staff.
- 4. Browser and device support: See Table 4 and visit https://www.dualinventive.com to find out which browsers and devices are supported by MTinfo 3000-Insight and the app. If needed, request support from Dual Inventive.
- 5. *NB-IoT connection requirement*: To use the functionality of the CRM 3000, a stable NB-IoT connection is needed. In areas with a poor NB-IoT connection, the CRM 3000 may lose its connection to MTinfo 3000-Insight. This means that no data is transmitted to MTinfo 3000-Insight.
- 6. App compatibility: To use the functionality of the app, use a compatible mobile phone.
- 7. Internet connectivity: Make sure the internet is always connected when working with the MTinfo 3000-Insight web or mobile app.

5 SAFETY

5.1 General

5.1.1 Intended use

For safe use, only use the CRM 3000 for its intended use.

5.1.2 Non-intended use

Non-intended use of the CRM 3000 can cause malfunctioning and unsafe situations like electrocution, fire or other dangerous situations.

5.2 General safety instructions

Specific safety instructions are part of the installation, preparation and configuration of the CRM 3000, which are described in these sections. In addition, follow these general safety instructions:

- 1. Installation of the CRM 3000 must be performed only when a *worksite is protected from trains*, by the relevant rail infrastructure controller's safe track access instructions.
- 2. Guarantee safety while installing the CRM 3000. The user is responsible for a safe installation. Follow the *local, national and organizational regulations and procedures.*



WARNING

The user is responsible for the safe installation of the CRM 3000.

5.3 Residual risks

Dual Inventive has performed a risk assessment of the CRM 3000 for the intended use and normal operating conditions. The following acceptable, residual risks are present with the intended use and the normal operating conditions:

6 INSTALLATION AND REMOVAL

This section describes how to install the CRM 3000 in the track and to remove it from the track.

6.1 Before Installation



WARNING

Before installing or removing the CRM 3000, check the worksite and make sure that everything is safe.

Before installing the CRM 3000, ensure that the CRM 3000 is functioning properly by checking its temperature in the MTinfo 3000-Insight web or the mobile app.

The last time the temperature has been updated, must be less than 2 hours ago and the measured temperature must be within the expected temperature range of its environment.


If the CRM 3000 is not working properly, wait one more hour because the data might be slightly delayed. If this does not help, <u>contact Dual Inventive.</u>

6.2 Installation



WARNING

Be aware of the risk of trapping your fingers and never place them on the magnetic side of the device.




- 1. Place the CRM 3000 on the shaded side of the rail to ensure that the rail temperature is measured correctly.
- 2. Place the CRM 3000 vertically so that the *ID* sticker is visible after placing it.

6.3 Removal



- 1. Place the thumb on the top of the device and grasp the bottom firmly with your fingers.
- 2. Pull up the device. If needed, use the foot of the rail as a grip point for your fingers.



WARNING

Do not twist and turn the CRM 3000 while it is installed on the track or attached to another metal surface. This can permanently damage the device.



7 CHANGING LOCATIONS

The CRM 3000 cannot automatically update its location. If needed, the asset's location can be changed manually through MTinfo 3000-Insight web and/or the app. There are two ways to do this:

- 1. Change the location by selecting a new location manually;
- 2. Change the location by synchronising it with your smart device's location.

7.1 Changing locations manually

The location of a CRM 3000 can be changed manually through MTinfo 3000-Insight web or the app:

- 1. MTinfo 3000-Insight web: go to the 'Assets' section and locate the device on the map. The CRM 3000 will be displayed on the map.
 - MTinfo 3000-Insight mobile app: go to the 'Assets' section and locate the device on the map. The CRM 3000 will be displayed on the map.
- 2. Click this button.
 - 3. Select where you wish to place the CRM 3000. Zoom in and out with the scroll wheel of your mouse or use the + and buttons on your smart device.
 - 4. Click the check button to confirm the device's new location OR click the cancel button to cancel the new location.

7.2 Synchronizing with a smart device's location

The location of a CRM 3000 can be changed by synchronizing it with a smart device's location through the app:

- 1. App: navigate to Map to see the device's location.
- Click this button to update the location.
 - 3. You can press this button to synchronise the location with the location of your device.
 - 4. Click the check button to confirm the device's new location OR click the cancel button to cancel the new location.

9 SERVICE

9.1 Service of CRM 3000 standard and VT

The CRM 3000 standard and VT service will be provided by Dual Inventive for up to *5 years* for free. In case of problems, please contact your Dual Inventive support team for assistance.

The CRM 3000 Variable Threshold (VT) device works practically the same as the standard version, except the standard version updates every hour and the CRM 3000 VT version updates based on the temperature it is measuring and its settings.

For CRM 3000 VT, if the temperature measurement hits a new threshold and it needs to start updating more frequently, it will immediately adjust this and send an update. For instance, if the device hits the 15-20°C range, it will upload the temperatures, and then send hourly updates until the temperature reaches a different range.

If the device drops to the below 15 degrees temperature range, it will send the next update at the following moment when it meets its new criteria, in this case within 2 hours, from the moment it detected this drop.

The CRM 3000 VT allows users to respond to emergency temperature increases or decreases without having to compromise significant battery life.

The CRM 3000 VT temperature ranges will be predetermined.

The CRM 3000 VT has a maximum of 5 temperature limits - these can be configured by the customer as well as the cut-off for immediate notification.

An example of such a CRM 3000 VT could be as follows:

| TEMPERATURE RANGE | UPDATE FREQUENCY |
|-------------------------|-------------------------|
| Below 15 degrees | Update every 2 hours |
| Between 15 – 20 degrees | Update every hour |
| Above 20 degrees | Update every 15 minutes |
| Above 30 degrees | Update every 5 minutes |

9.2 Lifespan

The lifespan of the CRM 3000 standard version is roughly 5 years.

The lifespan of the CRM 3000 VT would vary depending on the update frequency.

9.3 Warranty and delivery conditions

The CRM 3000 is supported by a lease contract that contains Dual Inventive's warranty and delivery conditions.
